



# REGULATION

## 1 REGISTRATION

- ▶ Registration is open to FICM member clubs / federations and also to crews not registered with the Federation who wish to participate in the event. The registration of the latter will be possible within the limit of 20% of the total.
- ▶ Reservations can be made starting from 1/12/2022 and until 03/15/2023 by connecting to the website: [www.eurocc2023.eu](http://www.eurocc2023.eu)
- ▶ The event is divided into two phases and it will be at the discretion of the participants to choose whether to join only the first phase or even the second.
- ▶ The registration forms will be processed in the order of arrival and within the limits of available places:
  - **FIRST PHASE:** EURO CC Assisi from 7 to 11 June 2023: MAX Registered participants 300 crews. The organizers will be able to decide on the execution of the event in the event that the minimum number of participants is not reached.
  - **SECOND PHASE:** EXTENSION from 12 to 18 June 2023. A visit to the most characteristic cities of Umbria is planned: MAX Number of participants 200 crews. The organizers will be able to decide on the execution of the event in the event that the minimum number of participants is not reached.
- ▶ An incomplete registration sent to the EURO CC secretariat will not be taken into consideration.
- ▶ Failure to pay the full amount for participation for the FIRST AND / OR SECOND PHASE of the event does not constitute a right to participation by the member.
- ▶ Registration applications will only be considered upon receipt of full payment. In the event that the payment is made after reaching the maximum number of participants, the registration may not be taken into consideration, proceeding with the reimbursement of the amount paid.
- ▶ Registration for the FIRST PHASE of the 44th EURO CC 2023 is essential to participate in the SECOND PHASE of the extension.

## 2 CANCELLATION OF THE EVENT OR RENUNCIATION OF PARTICIPATION BY MEMBERS

- ▶ In the event that by decision of the organizers or due to force majeure, it is not possible to carry out the event, a refund will be made equal to 100% of the amount paid with a deduction of € 30.00 per person for administrative costs incurred. Voluntary renunciation of participation for any reason will result in a refund of 70% of the amount paid if the cancellation occurs before 15/3/2023, while it will be impossible to return the amounts paid after that date.
- ▶ Participants who, being registered due to their own negligence, delay or impediment, do not show up at the 44th EURO CC in Assisi, at the "extension" or at the individual appointments provided for in the program for the various activities of the gathering, will not have any possibility of reimbursement of what poured out.
- ▶ After an initial notification of acceptance of the registration, the identification form and all the information necessary for participation will be sent to participants via e-mail by 04/16/2023. ## 4 GENERAL INFORMATION

- ▶ The arrival of the campers in the location destined for the "EURO CC VILLAGE" in Assisi is expected to start at 9:00 am on 7/06/2023. However, from 15h: 00 on 6/06/2023, a waiting car park will be available for those arriving early, which will allow them to wait for the assignment of the assigned station. The place that will be temporarily occupied for parking will be devoid of any service.

- ▶ Before arriving in the city of Assisi, make sure to place the identification form received on the windshield of the camper together with the blue FICM plate.
- ▶ In the event that the crew is equipped with a trailer, the organization does not guarantee the location of the appendix in the vicinity of the parking area of their camper.
- ▶ Once you arrive in the "EURO CC VILLAGE" area, you will find the parking attendants who will give instructions for placing the camper in the place assigned to you.
- ▶ Once the camper is parked, it is necessary to go to the WELCOME to register and collect the mandatory "identification badge" for each member of the crew.
- ▶ The use of personal data will be strictly used for the purposes of organizing the 44th EURO CC 2023 in application of the provisions of current legislation.
- ▶ It is mandatory to wear the "identification badge" both while staying in the "EURO CC VILLAGE", during guided tours and when traveling by bus.
- ▶ Participants, as far as possible, will be grouped by country of origin and by club they belong to.
- ▶ It is essential to arrive at the meeting place having already emptied the vehicle waste tank as well as the toilet cistern. It is also recommended to fill the drinking water tank. It will not be allowed to carry out these operations in the crew arrival phase.  
In the place where the event takes place during its first phase, the emptying of the toilet cisterns, the waste water tank and the filling of the clean water tank will be carried out without moving the campers; the times and methods for these operations will be communicated on site.  
Participants in the second phase will be promptly informed about the possibility of providing loading, unloading and electrical connection services in the places that will be visited.
- ▶ The site identified in the first phase does not provide for connection to the electricity grid.  
In the event that there is a need to connect for health reasons that must be highlighted and motivated at the time of registration, some stations equipped with electrical connections (low amperage) will be made available in a special area.
- ▶ The use of power generators is prohibited between 8:00 pm and 9:00 am.
- ▶ It is forbidden to light fires, barbecues, etc.
- ▶ Dogs must be kept on a leash and the owners must take care of collecting the droppings and throwing them in the appropriate containers. Animals cannot be allowed inside the closed places to be visited as well as on the means of transport.
- ▶ In case of inappropriate behavior, it will be at the discretion of the organizers to arrange for the crew to be removed from the venue. This will not entitle the defaulting party to a refund.
- ▶ Despite the provision of all safety conditions to guarantee the parking of vehicles, the participants in the rally are required to respect the instructions given by the staff. Everyone will be responsible for careless behavior that may cause damage to third parties.
- ▶ The organizers decline any responsibility in case of theft, damage or accidents that may occur during all the activities of the 44th EURO CC due to the behavior of the participants.
- ▶ The "extension" will begin on 12/06/2023 and will continue until 18/06/2023.  
In this phase the movements, where foreseen, will take place with their own camper dividing the participants into groups of up to 50 crews.  
The organizers will take care to bring together participants by nationality and / or by club provided this is possible.  
The program of visits and activities will be the same for all groups, but following a different path order that will alternate the visits in such a way as not to create excessive groupings of participants and guaranteeing everyone an identical itinerary and treatment.
- ▶ Each participant is obliged to comply with the health measures in force on the Italian territory.
- ▶ Participation in the 44th EURO CC 2023 implies acceptance of these regulations as well as the laws in force in Italy.
